AUTOMATED COMMERCIAL ENVIRONMENT/AUTOMATED EXPORT SYSTEM

Is your company exporting goods worth more than \$2,500 internationally? If so, you must file the electronic export information (EEI), which is electronic data containing export information. All EEI information goes to the U.S. Census Bureau, which evaluates export compliance and governmental reporting. It also enables the Bureau to compile U.S. export and trade statistics, which is in turn used by other government agencies for trade enforcement purposes. If it sounds serious, that's because it is!

The U.S. Foreign Trade Regulations make your company liable to the accuracy of filed (or not filed) information through AES. If the department finds inaccuracies or omissions in your documents, your company can face a penalty of up to \$10,000 per violation. It is too expensive of a mistake to make.

To prevent the headaches and anxiety caused that such complications could bring, simply use an automated export system (AES) compliant solution to simplify the filing process. Generally, it prompts you to enter all required information and double checks the completed fields before your submission to AES, which greatly reduces the occurrence of user errors.

Once you have sent your information to the Bureau, you would be able to ship out your shipments to your customer in no time. A quick turnover leads to customers who are satisfied and happy to work with you again.

Safely Identify and Ship Dangerous Goods

HAZARDOUS MATERIALS

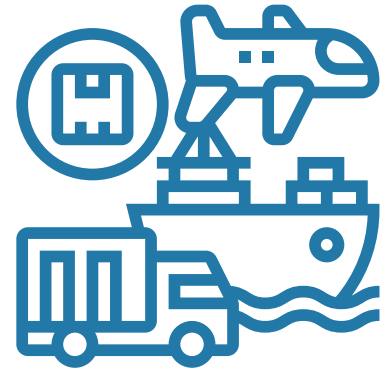

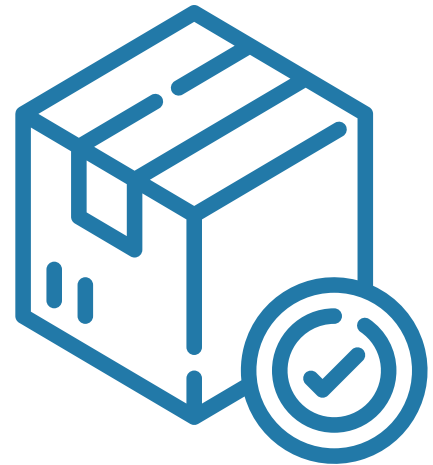
